1. IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.
3. Floors are hardwood in the gymnasiums and vinyl tiles in the breakout rooms. Balls will be orange Butterfly 40mm 3-Star Premium for all events except hardbat (see following). For the non-rating "Hardbat event" balls will be 38mm 3-star premium balls (Nittaku) or equivalent.

**Hardbat Event:** Current USATT rating system will be used for the purpose of conducting all draws with the exception of the hardbat event. For players that do not have a USATT rating, an estimated rating will be given based on a recommendation by a coach who knows the player or by visual evaluation of the player by the coach, whenever possible.
